I. DECLARATION

I, Envoy Prince Ra Hotep El, being of sound mind and lawful standing, declare under penalty of perjury that the following facts are true and correct to the best of my knowledge.

II. JURISDICTIONAL FOUNDATION

This Affidavit is issued under Common Law Authority, Consular Court Authority, Treaty Protections, and Constitutional Protections, including prior filings and recorded instruments.

III. STATEMENT OF FACTS

II. CONCLUSIONS
